Awards: Awards will be awarded for the divisions listed below:

BP: Mens Open: 1 thru 3 by wt. class.; Womens Open: 1 thru 5 (by formula) Teen: All teens (by formula,.) Best Lifter Awards: Overall best bencher
DL: Mens Open: 1 thru 3 by wt. class.; Womens Open: 1 thru 5 (by formula) Teen: All teens (by formula,.) Best Lifter Awards: Overall best deadlifter
2-Man DL: All lifters will receive an award, placings will be based on based on formula. Best Lifter Awards: Overall heaviest pull

What is the formula? The formula compares the lifter's bodyweight to their lift for a lb. for lb. ranking. **All teens will place if their entry is in on time.**

T-shirts: Mid America BP/DL T-shirts will be available for pre-ordering. Shirts will be \$14 (XXL & up, \$16) include size and amount when sending entry.

Drug Testing: Drug testing will be performed on at least 10% of the lifters at the competition. Andro and ephedrine products are illegal.

Rules: The competition will be conducted under the rules and policies set forth by the USAPL. No denim shirts will be allowed. No thumbless grips will be allowed. No velcro on BP shirts, all must be single ply. Lifters are required to wear a one piece singlet. For the deadlift long socks are required (*soccer type socks will work*)
